

Rules of the 1st 312 Solidària Call – Grants for Social, Sports and Environmental Projects in the Balearic Islands (2025–2026)

1. Purpose of the call

Mallorca 312, within the framework of its commitment to corporate social responsibility, launches the first edition of 312 Solidària, a call for grants aimed at supporting projects with a positive impact on society, especially in the social, sports and environmental fields within the territory of the Balearic Islands.

The purpose of this call is to promote initiatives that contribute to collective well-being, the practice of sport and environmental sustainability, fostering the values that inspire the spirit of Mallorca 312: effort, self-improvement, commitment and respect for people and the environment.

2. Categories

Three categories are established:

- **Social category**: Projects that promote inclusion, equal opportunities, health and well-being of people and communities in the Balearic Islands.
- Sports category: Projects that promote the practice of sport, especially among groups at risk of social exclusion, the promotion of grassroots sport, or the visibility of social causes through sports practice (for example, solidarity challenges linked to diseases or charitable causes).
- **Environmental category**: Projects aimed at preserving the natural environment, sustainability and the fight against climate change in the Balearic Islands.



3. Specific objectives by category

I. Objectives of the social category

Projects must contribute to one or more of the following aims:

- 1. Promote social inclusion, equal opportunities and the integration of vulnerable groups.
- 2. Strengthen community cohesion and citizen participation.
- 3. Enhance the physical, emotional and social well-being of people.
- 4. Improve accessibility to services, educational activities or cultural resources.
- 5. Combat dynamics of social, educational or territorial marginalization.
- 6. Promote personal and collective empowerment within communities or neighborhoods.

II. Objectives of the sports category

Projects must aim to:

- 1. Encourage sports participation among children, youth or groups at risk of social exclusion.
- 2. Promote grassroots sport and equal access to physical activity.
- 3. Promote values linked to sport: effort, self-improvement, cooperation and discipline.
- 4. Raise awareness of social, health or solidarity causes through sport.
- 5. Promote healthy lifestyles and inclusive sport.
- 6. Use sport as a tool for social cohesion and community development.

III. Objectives of the environmental category

Projects must contribute to:

- Conserving and protecting the natural environment and biodiversity of the Balearic Islands.
- 2. Reducing environmental impacts and promoting sustainable practices in communities or natural areas.



- 3. Promoting environmental education and public awareness.
- 4. Encouraging climate change mitigation or adaptation actions.
- 5. Regenerating natural spaces, habitats or degraded areas.
- Promoting responsible models of consumption, waste management or use of natural resources.

4. Financial Allocation

The call for projects for 2026 has a guaranteed total budget of €15.000.

The Jury responsible for selecting the projects to receive funding will freely determine the distribution of the financial allocation among them, taking into account their quality, impact and feasibility, and is not required to distribute the funds equally among the selected projects. In any case, the Jury may declare the selection of projects in one or more categories void, without this implying a reduction in the total budget provided for in the call.

5. Eligibility Requirements

Applications may be submitted by:

- Non-profit entities to which the tax regime established in Title II of Law 49/2002 applies, which have their registered office in or carry out their activities within the territory of the Balearic Islands.
- Exceptionally, and subject to a reasoned assessment by the Jury and the Mallorca 312 organization, applications may be accepted from other entities which, although not included within the scope of Title II of Law 49/2002, can demonstrate that they have continuously carried out non-profit activities related to the category applied for for at least the last three years.
- Each applicant may submit only one project per call.
- Projects must be technically and economically viable and must be fully completed before 31 December of the current year.



 Projects must be carried out entirely within the territory of the Balearic Islands before 31 December 2026.

6. Documentation to be submitted

Documentation must be sent by email to info@mallorca312.com before 15 February 2026, indicating in the subject line: "312 Solidària: Project Name".

Each application must include the following documentation:

- Application form.
- Project description report (maximum 5 pages) including:
 - o General description of the project.
 - Objectives and target audience.
 - Planned actions and timeline.
 - Expected results and impact.
- Detailed budget, with a breakdown of expected income and expenses.
- Brief presentation of the applying entity or individual, previous background and relevant experience.
- Authorizations, permits or licenses required for the execution of the project, where applicable under current regulations.

7. Timeline

- 17 December 2025: Publication of the call rules.
- From 19 December 2025 to 15 February 2026: submission of applications by associations wishing to apply for 312 Solidària.
- From 15 February to 1 March: Internal administrative review of applications.
- From 1 March to 15 March: Jury convening.
- 18 March: Jury meeting and resolution of applications.
- 16 April: Official 312 Solidària event. Announcement of winning projects or associations and award ceremony.



- The project justification report must be submitted within a maximum of two months after project completion and, in any case, before 31 January 2027.
- From April to December 2026: Project execution.

8. Jury and Evaluation Criteria

The jury will be freely appointed by Mallorca 312 and will include individuals of recognized prestige in the sports, social and environmental fields, as well as invited external collaborators (for example, athletes and public figures linked to the event).

The jury will evaluate applications according to the following criteria, with a maximum total score of 100 points:

Mallorca 312 may reject any project that does not adequately justify its alignment with the objectives of the call or whose feasibility, coherence or impact is not sufficiently demonstrated.



9. Obligations of beneficiaries

Beneficiary entities or individuals undertake to:

- Execute the project within the established timeframe, ensuring full completion before 31 December of the current year.
- Submit a technical and financial justification report within a maximum of two months after project completion and, in any case, before 31 January 2027.
- Publicly acknowledge the support of Mallorca 312 in all communications, dissemination or materials related to the project, including the use of the official logo and mentions on social media, press releases and graphic materials, subject to prior authorization from Mallorca 312 for logo usage.
- Participate, if requested, in the award ceremony and communication actions of the 312 Solidària project.
- Issue in favor of Mallorca 312 a certificate containing at least the following information:
 - Tax ID number (NIF) and identification details of the donor and the beneficiary entity;
 - Express mention that the beneficiary entity is included among the beneficiaries of patronage;
 - Date and amount of the donation;
 - Intended use of the donated funds in fulfillment of the entity's specific purpose or social mission;
 - Express mention of the irrevocable nature of the donation.

10. Acceptance of the Rules

The submission of applications implies full acceptance of these rules and of the jury's decision, as well as the commitment to comply with the requirements and obligations described herein.



11. Grant payment procedure

- 1. The amount granted to each project will be paid by bank transfer to the beneficiary entity or individual in three installments, according to the following schedule:
 - First payment (50%): during the month of May, once acceptance of the grant has been signed and the required administrative documentation has been submitted.
 - Second payment (25%): during the month of September, upon submission of a progress report or partial certification demonstrating the level of project execution.
 - Third payment (25%): after submission and validation of the final justification report, including technical and financial documentation.
- 2. All payments are conditional upon compliance with the obligations established in these rules and verification that the project is being executed in accordance with the approved proposal.
- In the event of total or partial non-compliance, non-execution of the project, or failure to submit justification documentation within the deadline, Mallorca 312 may suspend pending payments or require the full or partial reimbursement of amounts already paid.
- In duly justified cases, payment schedules may be modified or adapted to ensure project viability, subject to a reasoned request and express approval by Mallorca 312.

12. Technical and financial justification of the project

 Beneficiary entities or individuals must submit a final justification report within a maximum of two months after project completion and, in any case, before 31 January 2027.



2. The justification must include the following elements:

- Technical report, describing the activities carried out, results achieved and the social, sports or environmental impact of the project, accompanied by photographs and/or audiovisual materials evidencing its implementation.
- Financial report, detailing expenses incurred and income applied, accompanied by invoices, receipts or other valid supporting documents in accordance with current regulations.
- Certification from the project manager or the legal representative of the entity, attesting to the accuracy of the information provided and the proper use of the funds received.
- Mallorca 312 may request additional documentation, clarifications or supplementary checks to verify the correct execution and justification of the project.
- 4. If the project has not been fully or partially executed, or if irregularities are detected in the justification, Mallorca 312 may require reimbursement of the amounts received or deny pending payments, without prejudice to any other actions that may apply.
